3 Knowledge

3.1 Key Concepts

3.1.1 One

The concept of One is used in Science, where variables are isolated to determine predictable models – with the goal of narrowing in on single sources of truth, or explanations of complex problems in simple terms.

Organisations rely on the concept of “One” when employing Hierarchical leadership structures and decision-making approaches.

“One” can refer to the concept of a single source – a centre of All things – that which exists over, under, around, through, and within All Things.

Many religions define one single “God” as the creator and source of All power.

Individuals have one single core self that is unchangeable, despite emotions, moods, phases, environments, time, or identities.

3.1.2 All

“All” refers to the individual parts that make up everything.

When considering All Things, we are also considering nothing, as a part of everything.

All includes All People, All Living Things, and All Spirits/ Existences that might exist outside the world which we can tangibly perceive.

Organisations rely on the concept of “All” when employing collaborative team structures and group voted decision-making approaches.

Many religions define Gods, Angels, Demons, and/ or Other Forces which have responsibility/ accountability over, under, around, through, and within parts of All Things.

When considering All of an Individual, it includes every part of a Human including any new or existing identities, Body, Mind, Heart, Guts, Soul, Spirit, any parts which are connected to All other parts of Life or After-Life. ***We are considering that persons Everything.***

3.1.3 Science

A tool which has developed to understand One and All Things.

Generally, Science involves taking many complex variables, and seeks to isolate key concepts – confirming relationships and theories through testing that can be repeated.

This can be used for modelling and predicting behaviours and is utilised for developing technologies and approaches that can improve our experiences of life and the Human Experience.

Science does not have all the answers, and is constantly in a state of flux, where new and different theories can confirm, strengthen, weaken, or disprove previous versions, through changing variables, or considering different sets of basic assumptions/ beliefs. Ultimately, something is always lost when variables are isolated or removed from equations.

However, using notions which can be confirmed and repeated – especially the layers and contributing factors by which something is true or un-true – provides us with solid foundations for aligning approaches to Life.

3.1.4 Human Experience and Happiness

We know that the human experience includes the following components:

- Body
- Mind

In binary terms, this is our ability to think and act.

Beyond this, there are many concepts as part of the human experience which contribute to our engagement and happiness – which contribute to our lives.

These are more difficult to definitively define, where there are many complex interactions, yet they form part of our experience:

- Heart and Guts: Love and Effort.
- Physical Senses: Sight, Sound, Taste, Smell, Touch, Movement
- Mental Senses: Consciousness and Sub-Conscious
- Emotions: Our Moods and Feelings.
- Intimacy and Sexuality: Our deepest desires in Life.
- Energy: Flow.
- Soul and Spirit: Our deeply connected selves.
- Technology and Tools: Things which help us Do.
- Recreation and Entertainment: Things which help us Be.
- Nature and the Environment: The world around us – Life and After-Life.

- **Relationships:** The way in which All these Things are connected to other.

All People have a constructed notion of how these components relate to Life – to their Life and the Life of others. We can learn and share with each other – but everyone will always have preferences – the Things which resonate with them most closely.

3.2 Power Structures

Our world is managed through three main power structures:

1. **Government:** Governments provide administration to regions.
2. **Religion:** Religions/ Faiths provide frameworks for exploring the spiritual world and Life eternal.
3. **Organisation:** Organisations (including Companies and Institutions with a variety of ownership and management structures) provide products and services to people and the environment.

Governments, Organisations, and Religions can fall victim to over control, too much focus on money and profits, or moral superiority and hypercriticality.

The biggest challenges occur when the lines between these entities become blurred, for example, an Organisation seeking profit and strength for shareholders influences the way in which Governments control a region, OR a Religious movement seeking Spiritual Power influences on the investments and communication of Organisational Products or Services.

3.3 Our Identities

Our identities are established by our ability to think and act (body and mind) across a variety of settings, environments, and spaces.

All People will hold many identities throughout their life, and these will change across Time.

The most curious parts of our identity are the most sensitive topics including:

- Faith
- Politics
- Race, Ancestry, Family, and Biology
- Love, Intimacy, and Sexuality
- Concepts, Ideas, Things, and Stuff, which we most resonate with.

3.4 Our Rights

There are three types of Rights which All are unquestionably entitled too, as part of our existence with One:

1. Physical Human Rights
2. Virtual Human Rights
3. Environmental Rights

3.4.1 Physical Human Rights

The stronger we are as individuals, the stronger we All are.

Our physical rights include:

- Food/ Water
- Accommodation/ Shelter
- People/ Family/ Friends/ Community
- Movement/ Flow

Beyond this, our strength can be calculated via a range of criteria related to our Human Experience, Individuality, Connections, and Happiness. We have the Right for Freedom and Choice. We should have what we desire, so long as it's not harming anyone else.

3.4.2 Virtual Human Rights

Virtual Human Rights includes protection and ownership of our digital footprint and the data/ information available on our lives.

It also includes our Spiritual rights, as connected souls of Sun, Moon, Earth, Galaxy, and The Universe.

We must have the Right to ensure that which is related to ourselves is owned by each individual, and they have choice and sovereignty over the way in which their data or souls are used.

For this to be safe however, there must be mechanisms for protecting People, without sacrificing the fundamental Rights of All People and Things.

3.4.3 Environmental Rights

All Life has the Right to be protected, as does the After-Life or any other Phases, Forces, or Cycles that contribute to our existence.

The Space on planet Earth is limited, where there are the following requirements to sustain humans:

- Living
- Food
- Production

Beyond that, our Natural world includes many delicate ecosystems which sustains or influences All Life on the planet, including the environments where Humans live.

We know we must balance the resources of All Things.

We know that a few People control the majority of the Worlds resources.

We know that we must operate sustainably, in Living, Food, Production, and Nature, to continue – to survive – to thrive.

We know that we have Physical and Virtual Human Rights – that everyone has these Rights.

3.5 Performance

Life wants to perform at optimal levels.

One Person optimising their experience can cause conflict with the Rights of others.

People perform best when empowered.

People require direction to ensure they're focused.

If direction comes from too high or broad a level, it takes away from individual freedoms and Rights – the direction lacks context. Furthermore, it exacerbates the problem where one Person optimising their experience infringes on the Rights of others. **We know that the few people controlling the world have taken more from some, given more to others, but held the majority of resources and wealth themselves.**

If direction comes from too low a level, then it lacks context in the wider picture – the direction can be counter-productive to the Directions and benefits of others. We know that chaos can cause conflict and damage to People and Communities when it is managed in isolation of others – that there are often not enough resources to go around.

3.6 Constitutions and Agreements

Constitutions are the highest level of agreement in Governments and Organisations. They represent the most significant document for setting expectations, rules, and guidance's by which All People associated with that entity abide by. They are Agreements that hold the core Cultural Values of its People, Across Time, and thus are difficult to change at any point In Time.

We know that Constitutions are proud documents for Nations, as they establish a core shared identity – that is for All its People.

We know that People within an entity will continue to fight for their identities to be recognised by the agreement that holds it together, or otherwise detach from it.

We know that Communities, like People, operate best when they have individual empowerment, within a directed and focused framework.

We know that People hold many different identities, and hold pride in their relationships with Country, Community, and other People.

We know that People are governed by the values and moral codes of many different Constitutions and Agreements.

We know that many People don't like to formalise their relationships through signing off against documentation that outlines roles, responsibilities, expectations, conflict resolution approaches, etc – instead preferring agreements that are more fluid, adaptable, and based on agreed core values.

We therefore KNOW that our highest level of Constitution MUST be clear, accurate, connecting, and inspiring, while **protecting the Rights of All its People**, including

enabling and empowering its People to make Agreements with other People and Entities. We know that establishing core values based on characteristics beyond a Persons reasonable control is not fair – for example, Constitutional Rights should not discriminate against Things like race, gender, sexuality, spiritual alignment, intelligence, or wealth.

4 Passion

Passions drive our beliefs.

Our beliefs define us.

Our beliefs influence and are influenced by our interactions with others.

Our beliefs evolve as we learn and grow.

Our beliefs can fill us with alignment, strength, and power (Passion), or can limit our ability to perform to our potential.

We can become most emotional, judgemental, or vindictive when others hold beliefs that don't align with our own.

We have a right to hold our own beliefs and should be encouraged to explore them throughout our own journey.

When beliefs clash, it can cause negative and damaging outcomes, which can be used to benefit some at the expense of many.

This section presents beliefs of the author, with a view of encouraging openness, respect, and understanding.

4.1 God

No Government, Organisation, Religion, or Individual owns the Word of God – no Words have come directly from One Source – instead People have been inspired, commented, and/ or acted on greater or deeper understandings of our world.

Therefore, no Religion, Organisation, Government, or Individual can own the Word of God. Instead, Spiritual texts must be considered in the light and dark of the Time, Space, and Identities of the People who are uncovering them.

However, while there are regional differences, there are many similarities in the teachings of the Spirit world, After-Life, Energy, and Love.

Furthermore, a concept of “a” God, and “the” Gods exists in most religions, faiths, communities, and theories – although often different names, stories, and logics are used to explain and understand the same concepts.

There is God, an Energy, a Force, that runs through, over, under, around, and within All Things. All People can integrate, connect with, feel God. There are People who are closer to God, either through practice or natural gift – Gods, Angels, Demons, the Light and Dark of our world. **Evil exists not within general categorisations of anything, but in behaviours associated with war, battle, separation, isolation, or general terror/fear mongering.**

God is not the representation of All that is Good in the world – of All that is Right – otherwise the distinctions and achievements between Faiths and Communities developed in different regions, holding differing pros and cons, would not have been possible.

Instead, God is balance – the centre of the pendulum – as well as existing on the Left and Right of the pendulum – and being the pendulum itself.

This is blasphemy by many definitions of God – where the successes of current and previous Souls are presented as evidence for this belief. Indeed, pouring Energy into a concept – Person, Idea, Word – it is strengthened or weakened. Thus, we have the power to shape our creator – on this planet, we have the power to influence God.

4.2 Spirit and Soul

If you are to imagine the greatest leader of All Time, they will still only ever be one person. A person who could be anything, but they can’t be everything.

The greater the reliance on any one individual, the bigger the risk to All Others, should anything happen to that person e.g. they become unwell, incapacitated, or corrupted in some way. While great leaders can achieve many positive outcomes with more power and freedom to act, leaders with personal or compromised interests can cause great damage.

Therefore, ensuring there is appropriate segregation of duties, support, and governance around the role is part of defining a new Head of State for Australians.

However, we see throughout history, that moods, opinions, Sciences, Religious/ Spiritual leanings, and senses of morality can change. In times of turmoil, these can confuse the Things which are most important – our fundamental Rights as People can become lost.

Our Rights as People include:

1. Physical Rights
 - a. Food and Water
 - b. Shelter
 - c. Movement and Social Interactions
 - d. Free Speech
 - e. Trusted Information Sources
 - f. Are There Others Important to You?

2. Virtual Rights
 - a. Ownership of Individual Identity
 - b. Ownership of Personal Data
 - c. Free Religion/ Belief/ Faith
 - d. Freedoms from Persecution/ Judgement
 - e. Guidance/ Controls/ Encouragements over Technological, Spiritual, and Sexual Energy Exchanges

3. Environmental Rights
 - a. Land Ownership and Usage
 - b. Water Ownership and Usage
 - c. Sky Ownership and Usage
 - d. Animal (Domestic, Farming, Native) Ownership and Usage
 - e. Plant (Domestic, Farming, Native) Ownership and Usage

It would be extremely challenging to have the definition of an entire package of Rights developed and signed off by the Australian People. There is therefore a reluctance to cloud the question of Australian independence with these more complex issues. However, these are the most important issues to the daily experiences of All Australians.

It is proposed that Rights are presented in packages, where Rights are grouped together and voted on separately from wider, more connected issues. However, great caution must be applied to votes by the General Public, as throughout history, we see much evidence of mistakes being made by majorities.

Regardless of the approval process, the engagement of the Australian People in determining which Rights are most valid and resonate with them is critical. In addition to this, there must also be consideration to the Rights and issues most important to minority groups – where it might be more difficult for a majority to even understand the implications, let alone approve them.

Where something can't be resolved Constitutionally, there will remain Laws, Legislations, and Policies to Protect the People, which elected Governments and Courts of Law continue to manage. However, where issues effect All Australians, and are Universal, every effort should be made to have them included Constitutionally.

Ultimately, The Way boils down to four main Things to focus on as part of updating the Australian Constitution:

1. An Australian Head of State: With Governance Controls
2. Physical Rights
3. Virtual Rights
4. Environmental Rights

6.1 An Alternative or an Addition..?

This paper considers a World of Peace! Of Wonder, Excitement, and Fun.

It proposes that this is achieved through updating our Australian Constitution – the document that defines the shared values and agreed principles of the Nation.

The paper suggests that if Australia, one of the luckiest counties on earth, can establish Universal Principles for managing its Governance, Leadership, Physical Rights, Virtual Rights, and Environmental Rights, this same model could be used around the globe for aligning what connects us, what unites us, what is the same. That we can redistribute resources used for our divisions and separations to that which we need, want, and desire!

What a phenomenal prospect! A truly united world – not achieved through war, but through connection, values, and shared understandings.

The existing world – a world of Empires, Globalisation, and Fake News – a world of Patriarchy, Hierarchy, and Man – places great emphasis on Identities, where certain Things are only available to People holding certain identities.

Other worlds fight for dropped identities, where there is surrender to larger forces or greater wisdoms.

Stronger than any of these worlds, stronger than Man or Woman, stronger than Spirit or Soul, stronger than Body or Mind, stronger than God or the Forces of the Universe, **is the Force of Love.**

Love has many layers – the Love of Self, the Love of Things, the Love of Concepts/ Ideas/ Beliefs, the Love of Family/ Friends/ Community, the Love of Intimate Partner/s.

Some argue that there is no greater act of Love than holding firm in your identity. Others, that there is no greater act of Love than giving up your identity altogether.

To be completely identity-less might be considered as becoming one with Spirit (or the Force) – that which connects All Things together. However, without identity, an Individual would not hold memories, would not hold desires for the future, would not hold Love in any one Thing – they would simply Be in the present. Without identity, it is difficult to identify the humanity in that Individual – it is difficult to engage on shared topics of understanding and connection – it is difficult to trust, actually, in many modern settings, it is not technically possible to trust that Individual.

Yet, to surrender your identities TO something or someone, is the greatest form of Love you can gift. Usually, partnerships are formed when identities can be shared for mutual benefit, where there is an agreed (formally or informally) and deeply understood hierarchy of priorities when facing conflicting identity interests – i.e. there is only so much of ourselves – so much of our All, our Everything – that we are willing to give up for someone or something else.

More important than our Constitution or identities, is Love! Love our Family, Love our Friends, Love our Communities, Love our Concepts, Ideas, Beliefs, Love our World, the Land, the Water, the Sky, Love God/s/ the Force/s, to Love Ourselves.

We must understand that with this Love comes senses of protection.

We must understand that this Love exists in Everyone – that Everyone will seek to protect that which they Love.

We must understand that letting something or someone go can be as significant expression of Love as holding onto something or someone.

We must appreciate that we can change our identities – we can change the hierarchy's of our Love – they are not fixed, but the constant is Love itself – where the greater the commitment, the greater the expression of Love.

Through Loving ourselves, AND respecting/ supporting where possible, the Right for All others to Love in their ways – each other's boundaries, AND through open dialogues on the benefits and dangers of different types of Love, we embrace the Age of Love that surrounds us everywhere, always.
